Communications:

- COVID 19 update
 - o Continual Change in guidelines; City is practicing social distancing.
 - The City Hall lobby is still closed to the public. Things are running smoothly. Customers use the drop box and mail for returning payments and paperwork. If needed, the ladies will meet customers out-front. The City staff is and has been present every day.
 - Houston County had 10 cases from March until last week, now Houston County is at 15. Mayor Bailey ask that everyone be careful.
 - o Mayor Bailey is not going to mandate the wearing of masks. That will be left up to the Governor. Each person can make their own choice to wear or not to wear.
 - o Mayor Bailey ask that everyone continue to practice good hygiene and take precautions.

Committee Meetings:

Discussion:

The need for a guard rail extension on Tank Hill Road was discussed. The new section would connect to the current guard rail and extend to the Griffey Hill Road area. Multiple auto accidents have occurred in this area. Also discussed was the need for signage for speed and curves ahead to be installed.

Officer Justice Perigo gave the Police Report for the month of June: A total of 284 calls answered; 50 citations were issued; 8 arrest were made; 2 accidents (without injuries)

Chief Warren provided the Fire Report for the month of June: the department responded to 4 reports of structure fires, 4 wrecks, 2 EMS assists, and 1 gas leak. 1 fire and life safety inspection were completed at a commercial structure. 2 municipal burn permits were issued. Firefighters trained on wildland fire operations and firefighter rehab and fitness.
