Old Business:

Motion

to approve Ordinance 629, an Ordinance to amend title 8 of the Erin Municipal Code by establishing Liquor by the Drink Regulation on second reading was made by Ligon and second by Gooden. Roll call vote as follows: YES – Ligon, Baggett, Mitchum, Moore, Warren, Gooden, Carson. NO – Parchman. Motion carries.

New Business:

Motion

to approve Ordinance 630, and Ordinance to Establish an Updated Occupational Safety and Health Program Plan, Devise Rules and Regulations, and to provide for a Safety Director and the Implementation of Such Program on first reading made by Baggett, second by Ligon. Roll call vote as follows: YES – Ligon, Baggett, Mitchum, Moore, Warren, Gooden, Carson and Parchman. Motion carries.

Motion

to approve RESOLUTION 12.01.2020, a resolution to accept and award the bid of the 2020 Sewer System Improvements – Sewer Line Relocation to Parchman Construction Company of Cumberland City, Tennessee with a base bid amount of \$30,424.23. This project is located between Wells Creek and the Cross Roads (intersection of Hwy 13 and Hwy 49) and will use approximately 195 L.F. of 8 – inch Ductile Iron Sewer Line, install (2) additional manholes and tie into the existing manhole. Motion to accept made by Gooden, second by Warren. Roll call vote as follows: YES – Ligon, Baggett, Mitchum, Moore, Warren, Gooden, Carson and Parchman. Motion carries.

Motion

to approve RESOLUTION 12.02.2020, a resolution to accept and award the bid for the City of Erin Waste Water Treatment Plant Improvements. This portion of the project to is construct a new sewer plant (all cost associated with the labor, materials, equipment, and incidentals necessary for the required demolition, construction, testing and placing into operation for the new Waste Water Treatment Plant, and the rehab of current office / lab spaces, pump rooms and treatment unit tank / drying bed facilities, all in accordance with the specifications and drawings). A total of (5) bids were received and reviewed. The bids received were more than anticipated, but Rural Development has assured the City of Erin that all funding necessary for this project will be obligated in the form of additional grant and loan money. The award goes to the low bidder of W & O Construction of Livingston, TN in the lump sum bid amount of \$6,278,000.00. Motion to accept made by Moore, second by Gooden. Roll call vote as follows: YES – Ligon, Baggett, Mitchum, Moore, Warren, Gooden, Carson and Parchman. Motion carries.

Proclamation

Mayor Bailey read a Proclamation presented by the Houston County Historical Society honoring Houston County on its 150th birthday on January 21, 2021, establishing that day as a day of celebration. Mayor Paul Bailey and all Alderman for the City of Erin signed the Proclamation and it will be presented to the Historical Society for remittance to the Houston County Archives.
